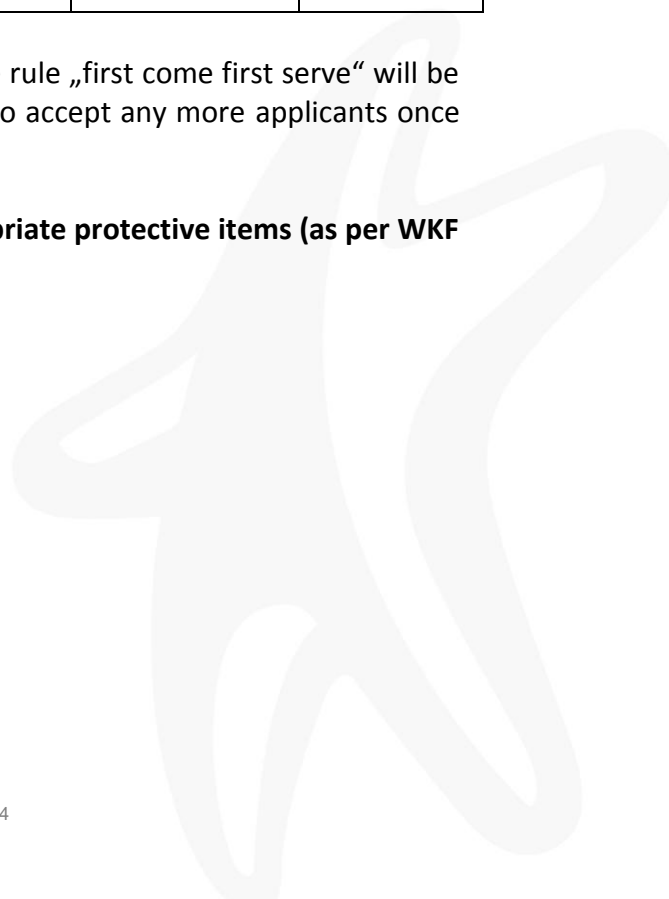

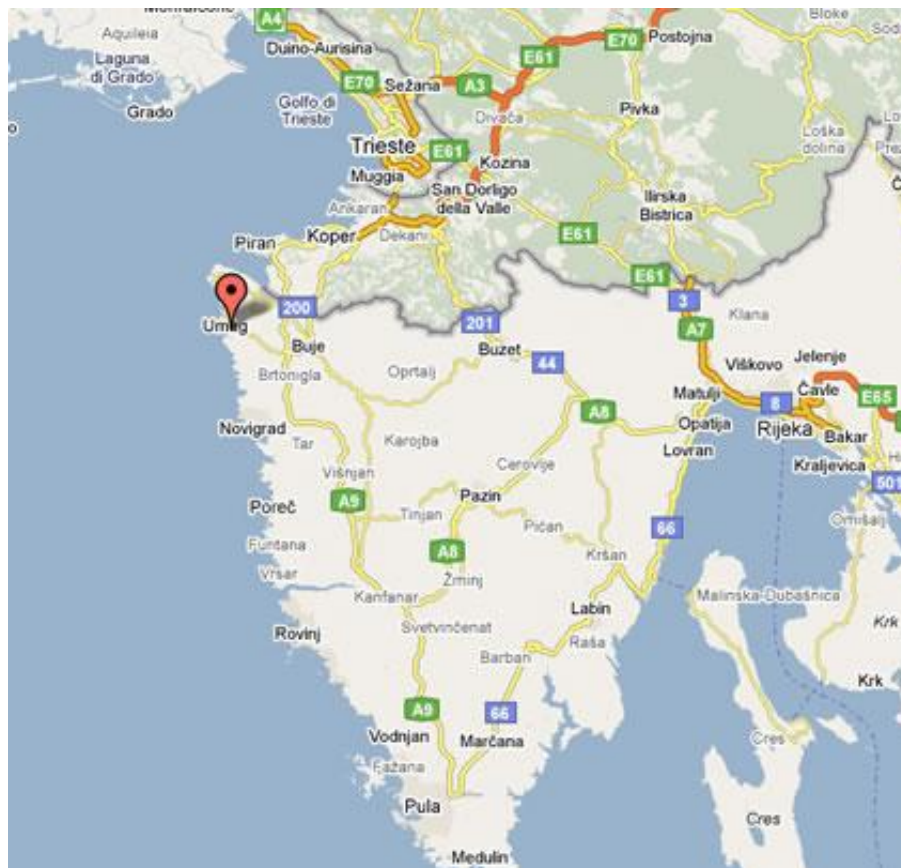
ABOUT CROATIA:

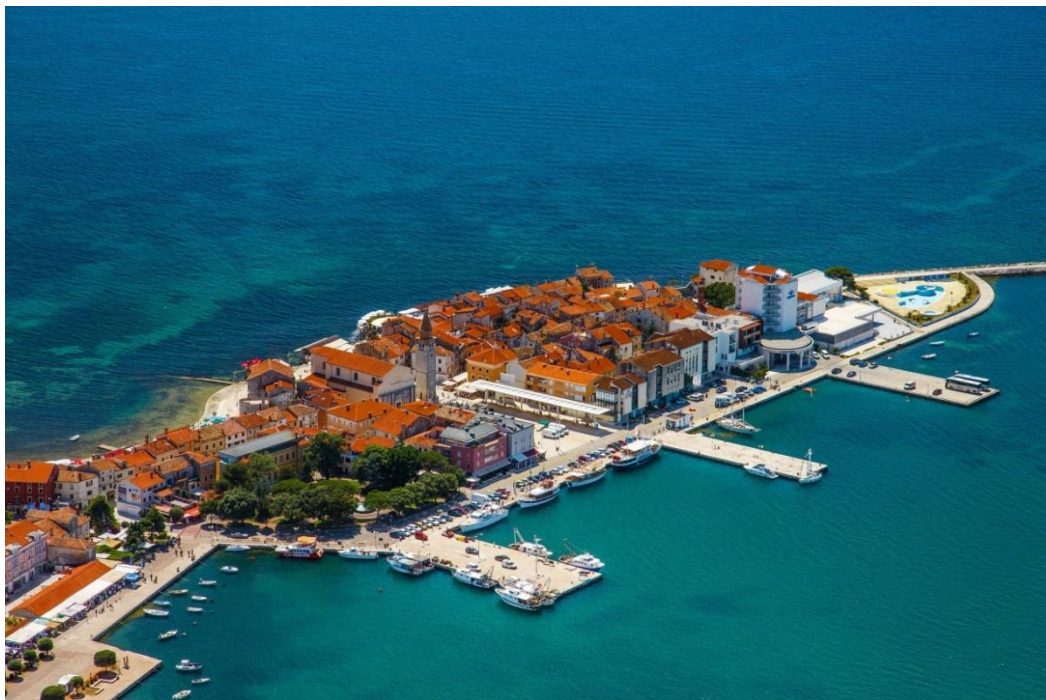
Croatia officially the Republic of Croatia (Croatian: Republika Hrvatska) is a unitary democratic parliamentary republic at the crossroads of Central Europe, Balkans, and the Mediterranean. Its capital and largest city is Zagreb. The country is divided into 20 counties and the city of Zagreb. Croatia covers 56,594 square kilometres (21,851 square miles) and has diverse, mostly continental and Mediterranean climates. Croatia's Adriatic Sea coast contains more than a thousand islands. The country's population is 4.28 million, most of whom are Croats, with the most common religious denomination being Roman Catholicism. Croatia became the 28th member state of the European Union 1 July 2013.



Umag in Istria is the first city you will reach when approaching Istria from Western Europe. Umag conquers with its allure, diversity and richness of the tourist offer. Umag is a town of around 13,000 inhabitants which with about 45 km of the coastline and interesting hinterland integrates special features of the whole region and might be the best introduction into a different experience of the Mediterranean. 10. Annex I “WKF Coach Activities”

Welcome to the WKF coach license program for Umag 2014. The coaches program is proving to be a great success, after the first year of its implementation we already have over 500 registered coaches. This program is proving its capacity to standardize the coaches’ function and thereby make our competitions safer, further enforcing the anti doping rules as well as enhancing disciplined and courteous behaviour overall. This year coaches will be able to access both coach levels, either the WKF Accredited Coach or the WKF Certified Kata and/or Kumite Coach.

Those coaches who wish to attend the “Accredited Coach Briefing” in Umag must fill out the registration form and agreement enclosed in the bulletin as well as register online for the event. The documentation must be sent to the following email addresses: wkf@wkf.com.es and aaust186@bigpond.net.au no later than May 30th. Those Accredited Coaches who wish to take the “Certified Kumite and/or Kata Coach Exam” in Umag do not have to sign the agreement again; they need to send the registration form included in the bulletin and register online by May 30th.

☞ **Please note that only coaches in possession of the “WKF Accredited Coach” level have access to the “Certified Kumite and/or Kata Coach Exams”.**

☞ **Please note that it is not possible to take part in both the “Accredited Coach Briefing” and the “Certified Kumite and/or Kata Coach Exams”.**

The WKF must receive the corresponding payments by bank transfer to the account indicated in the registration form (including all bank transfer charges). **In order to ease the process all the payments must come from National Federations, not individual coaches.** All bank transfers must be received at the WKF bank account **no later than May 30th**.

Finally, the “Accredited Coach” diplomas will be handed out in Umag, each individual is responsible for picking up their diploma and **those coaches who do not do so will be charged with the shipping costs incurred by sending their diploma to their National Federations.** The “Certified Kata and Kumite Coach” diplomas will be sent by regular mail via the National Federations to those coaches who pass the exam.

☞ **Remember that no coaches can perform such function in WKF Championships if not in possession of the WKF Accredited Coach level.**

The undersigned hereby agrees to conform to the following conditions as a prerequisite for coaching at WKF events and obtaining and maintaining WKF coaching licenses:

As a coach I am responsible for:

1. the safety and well being of all athletes assigned to me by my National Federation, both inside and outside the competition area;
2. the courteous and disciplined conduct of myself and my assigned athletes, both inside and outside the competition area;
3. the adherence of myself and my assigned athletes to instructions given by the referee or other empowered tournament officials;
4. the adherence of my assigned athletes to the current anti-doping rules;
5. to keep myself abreast of current competition rules and ensure that my assigned athletes abide by the same rules;
6. avoiding protests without basis in the rules.

I hereby confirm that I understand that by non-compliance of this Accreditation Agreement may forfeit my right to coach at WKF events, and that such non-compliance may result in the revocation or suspension of any coaching license issued to me by the WKF, based on the decision of the Technical Commission.
